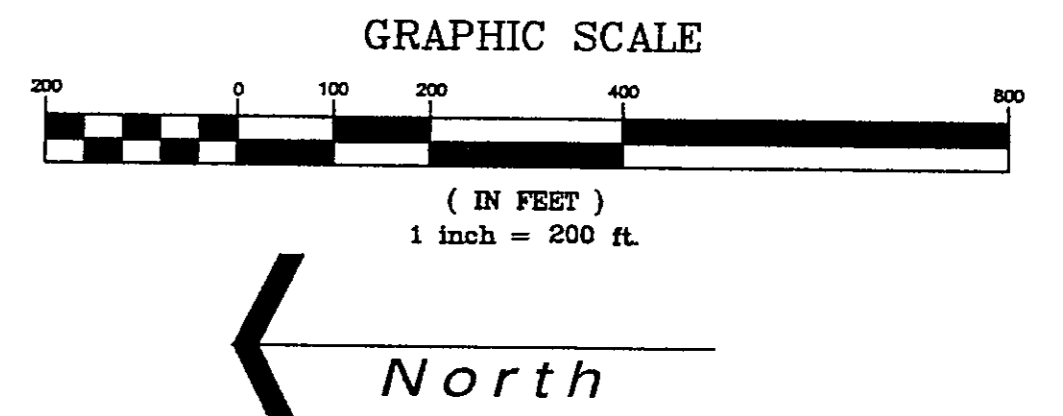


Golf Course Parcel 3

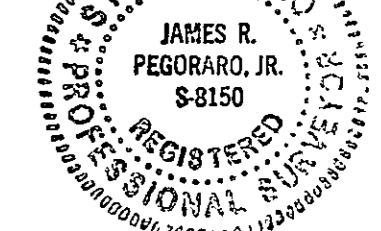

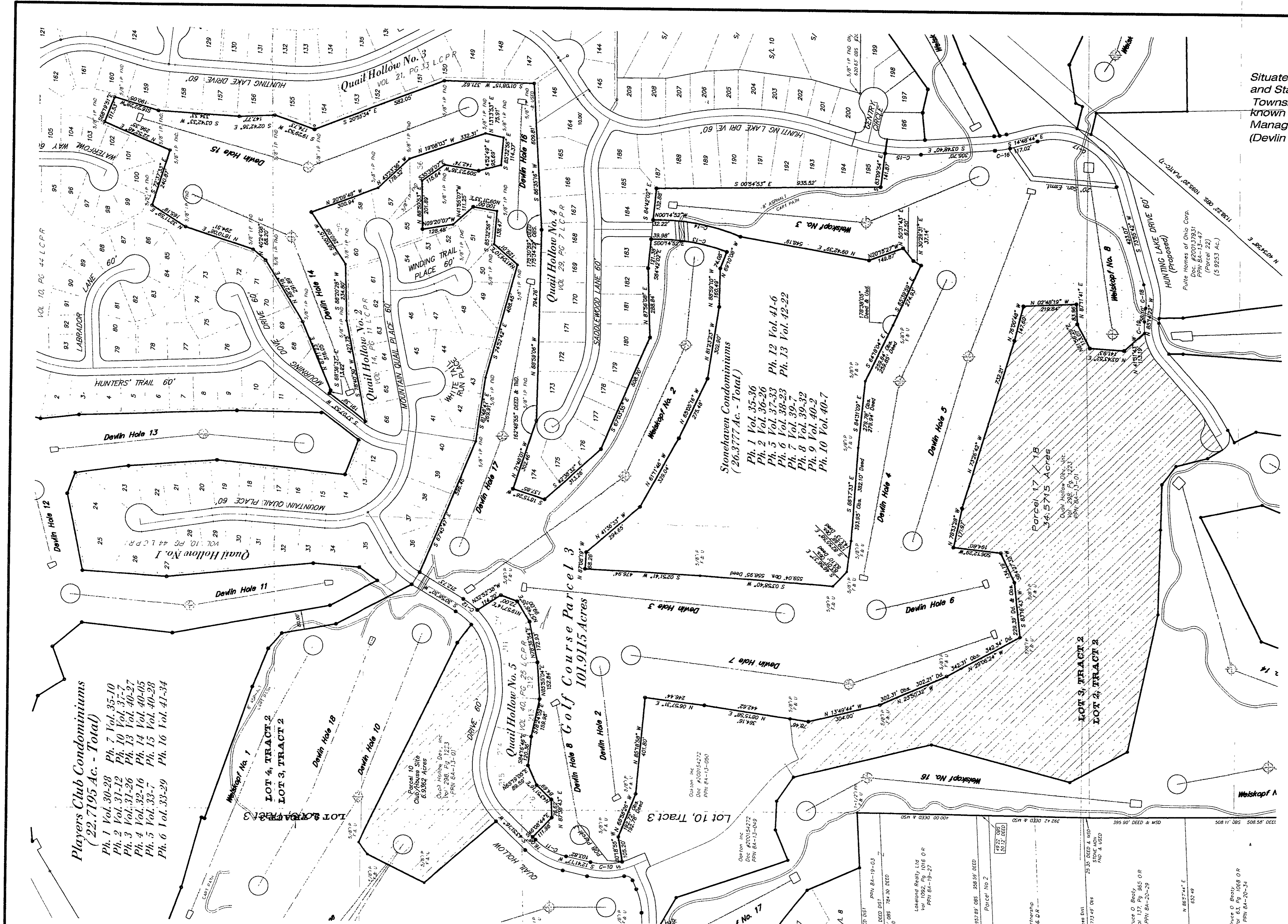
