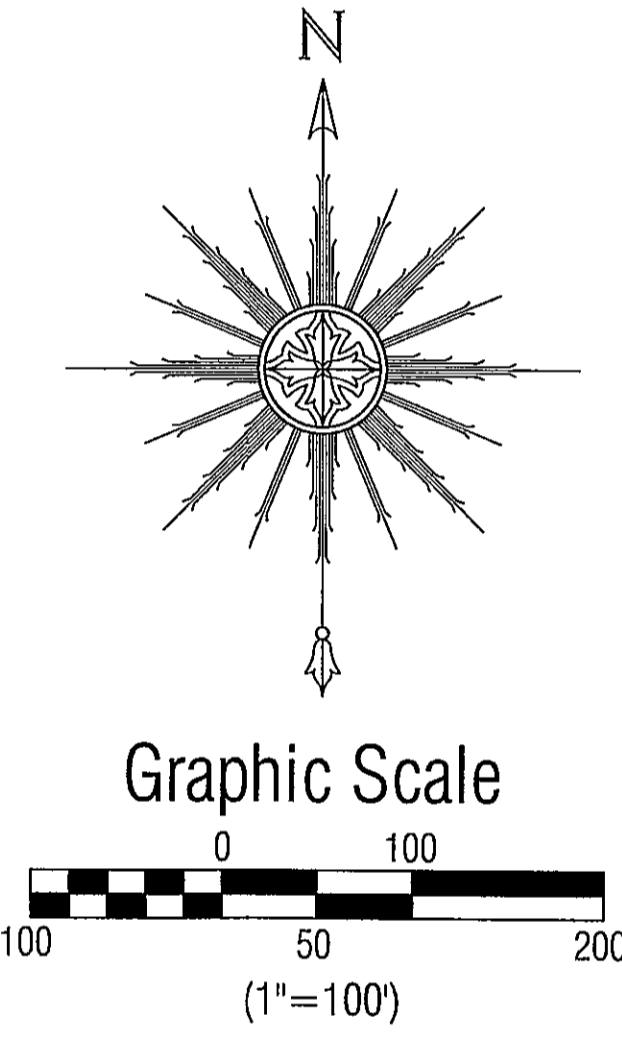


Plat of Lot Split and Consolidation - Prepared for Jodi Naji

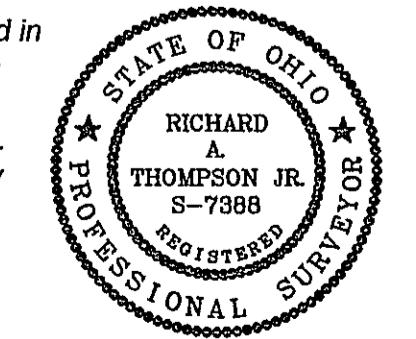
