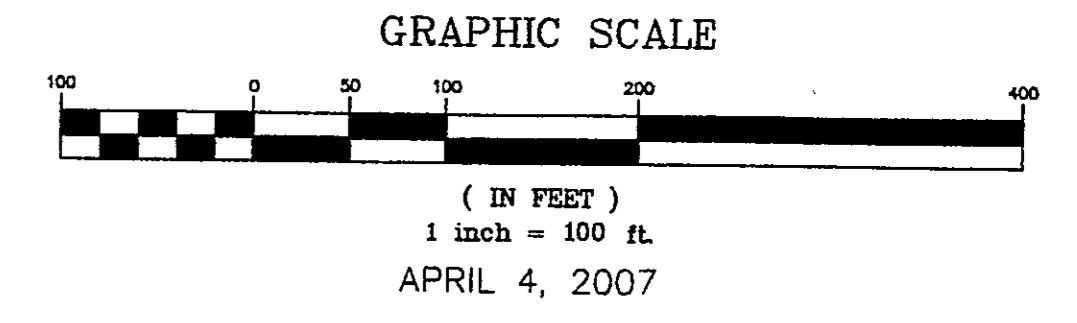


**PLAT OF SURVEY AND LOT SPLIT

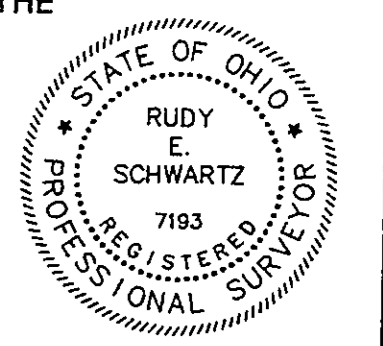

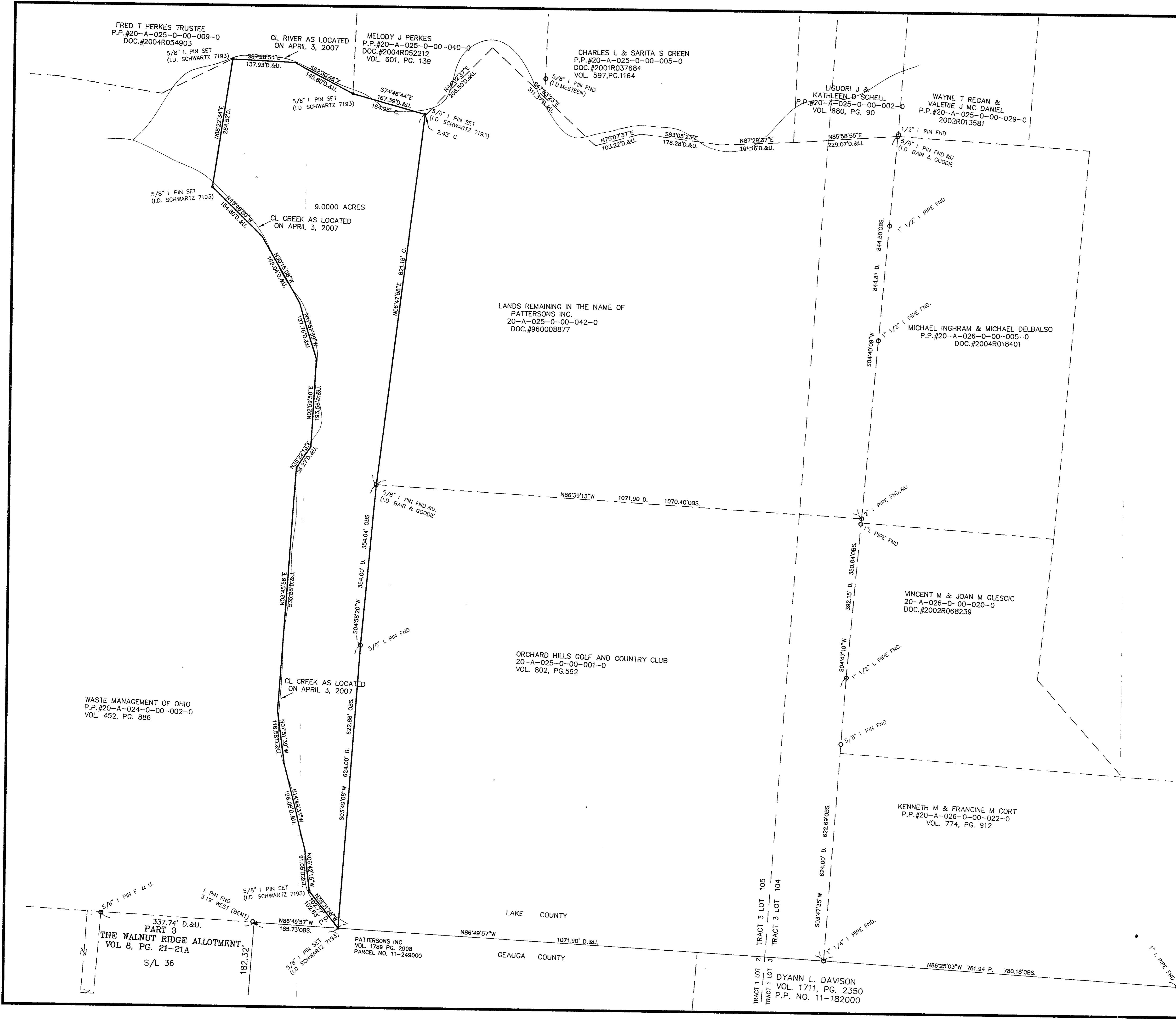
