

ORDINANCE NO. 1945-19

AN ORDINANCE CHANGING THE NAMES OF CERTAIN STREETS AND AVENUES IN THE VILLAGE OF WICKLIFFE, OHIO.

Whereas during the growth of this Village several streets located in different parts of this Village were designated by identical names, and  
Whereas this Council employed the services of Mr Gerald Murphy, an expert in house numbering and street naming, to establish house numbers and to suggest the re-naming of streets in this Village pursuant to a plan, and

Whereas said plan has been completed and approved by this Council, and  
Whereas it is the desire of this Council to give effect to said plan and thus eliminate the confusion resulting from streets in this Village having the same or similar names,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF WICKLIFFE, LAKE COUNTY, OHIO:

Section 1. That the names of the following streets shall be and they are hereby changed to the following names and/or numbers:

- East 279th Street to Craneing Road
- East 280th Street to Bishop Road
- Ashmere Court to Ashmere Street
- East 283rd Street to Depot Street
- East 284th Street to East 290th Street
- East 285th Street to East 291st Street
- East 286th Street to Maple Street
- East 287th Street to Lincoln Road
- Third Avenue to East 293rd Street
- Second Street to Silver Street
- East 289th Street to Silver Street
- First Avenue to East 294th Street
- East 290th Street to East 294th Street
- East 291st Street (formerly Bell and Station Streets) to Rockefeller Road
- East 292nd Street (from Clayton Avenue to Euclid Avenue) to Bellview Street
- East 293rd Street (southerly from Euclid Avenue to Willow Avenue) to East 296th Street
- East 294th Street (southerly from Euclid Avenue) to Robindale Street
- East 295th Street (southerly from Euclid Avenue) to East 298th Street
- East 298th Street (formerly Mosher Avenue and Oakdale Avenue) to East 300th Street
- Arbor Road to Arbor Street
- St Clair Avenue to Lakeland Boulevard
- East 283rd Street (northerly from St Clair Avenue) to East 290th Street
- East 284th Street (northerly from St Clair Avenue) to Clark Street
- East 285th Street (northerly from St Clair Avenue) to East 291st Street
- East 286th Street (northerly from Lakeland Boulevard) to Eagle Street
- East 299th Street (from Jackson Street northerly and thence westerly to Buena Vista Drive) to Delaware Street
- Delaware Street (extending in a general easterly and westerly direction from the southerly end of Silver Street) to Park Street
- Delaware Street (extending westerly from East 296th Street) to Wood Street

Section 2 This ordinance is hereby declared to be an emergency measure, and provided it receives the affirmative votes of two-thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest time allowed by law.
