

**AGREEMENT
AND**

Resurvey of Sublot Nos. 53 and 76 in Merchants Survey

Witnesseth that the above named parties are the record
owners of contiguous parcels represented on the survey
shown below, and said parties are in actual possession of the res-
pective parcels indicated by the lines bounding their respective
names.

Whereas the boundaries of the parcels conveyed to said
respective parties do not wholly coincide with the boundaries
of the respective parcels as occupied by said parties.

Whereas the parties hereto are desirous of fixing once and
for all time the sites of the dividing lines between their
respective parcels.

Now it is expressly agreed by and between the parties
hereto, their respective consorts and mortgagees who have
acquired rights in said respective parcels either by grants or
operation of law, that the within survey and map made by,
HOMER A. COLE, dated May 24, 1947 showing the boundaries
of and dividing lines between, said parcels, is a true and correct
survey and plat, and that the lines as shown here on as
the boundaries of our respective parcels are the true and
correct boundaries of our respective parcels, and we do hereby
accept this survey and plat and the lines, monuments, and
boundaries to be correct and do hereby establish each res-
pectively, the lines shown here on to be correct, in formal
compliance with Sections 8533 and 8534 of THE OHIO
GENERAL CODE.

This agreement shall be binding upon and inure to the heirs
executors, administrators and assigns of the parties hereto.

this survey together with the agreement herein contained.


